PETITION.

To the Honorable Henry Horner, Judge of the Probate Court of
Cook County.

The undersigned, Corinne Dorothy Hill, as Executrix
of the Last Will and Testament of William Wallace Hill, deceased,
respectfully represents and shows unto your Honor that the said
William Wallace Hill was, at the time of his death, and had there-
~~before~~ been ever since about the first day of January, 1921, in
the employ of Hill, Joiner & Co., a corporation organized under
the laws of the state of Maine and having its principal place of
business in Chicago, Illinois; that said employment was under and
in pursuance of a certain written agreement between the said
William Wallace Hill and said Hill, Joiner & Co., dated the 1st
day of January, A. D. 1921, as amended and extended by a certain
supplemental agreement in writing between the said William Wallace
Hill and said Hill, Joiner & Co., bearing date the 30th day of
December, 1922; that under the terms and provisions of said agree-
ment and supplemental agreement the said William Wallace Hill was
to receive a certain sum, payable monthly, as salary, and in addi-
tion thereto was to receive a portion of the yearly net earnings
of said Hill, Joiner & Co., if and in the event said yearly net
earnings exceeded seven per cent of the net assets of said Hill,
Joiner & Co.; that said Hill, Joiner & Co. paid to said William
Wallace Hill during his lifetime the said monthly salary speci-

fied in said written agreement as said salary became due and able under the terms of said written agreement; that the said Hill, Joiner & Co. also made full settlement with said William Wallace Hill for the portion of the net earnings of said Hill Joiner & Co. for the calendar year 1921, to which said William Wallace Hill was entitled under and by virtue of said written agreement; and that said Hill, Joiner & Co. has made full settlement with the undersigned, as Executrix of the Last Will and Testament of said William Wallace Hill, for the portion of the net earnings of said Hill, Joiner & Co. for the calendar year 1922, to which said William Wallace Hill was, at the time of his death entitled under and by virtue of said written agreement; that the portion of the net earnings of said Hill, Joiner & Co. for the calendar year 1923 to which the undersigned, as such executrix, will be entitled under and by virtue of said written agreement and written supplemental agreement cannot be determined until after the close of the calendar year 1923, but the undersigned is informed and believes that the same will be much less than the sum of six thousand dollars; that Hill, Joiner & Co. has offered to pay to the undersigned the sum of six thousand dollars in full payment, satisfaction and discharge of all claims and demands which the said William Wallace Hill had at the time of his death or which the undersigned or any future representative of his estate has or may hereafter have against said Hill, Joiner & Co. for or on account of any matter or thing whatsoever, and particularly all claims and demands under, or arising out of, the said written agreement and supplemental agreement, or either of them.

And the undersigned represents and shows unto your Honor that she believes that it will be to the best interest of the estate of said deceased to accept said offer and to make such settlement.

Wherefore she prays that she may be authorized by the

court to make settlement with said Hill, Joiner & Co., and, upon the payment of the sum of six thousand dollars to her by Hill, Joiner & Co., to release and discharge said Hill, Joiner & Co. from and of all claims and demands, of every kind, nature and description, which the said William Wallace Hill had at the time of his death or which the undersigned or any future representative of his estate has or may hereafter have against said Hill, Joiner & Co. for or on account of any matter or thing whatsoever, and particularly from and of all claims and demands under, or arising out of, the said written agreement and/or supplemental agreement between the said William Wallace Hill and said Hill, Joiner & Co.
