PETITION FOR WAIVER OF SECURITY AND FOR
WAIVER OF REQUIREMENT OF PUBLICATION OF
NOTICE FOR ADJUSTMENT OF CLAIMS.

TO THE HONORABLE JOHN F. O'CONNELL, JUDGE OF THE PROBATE
COURT OF COOK COUNTY, ILLINOIS.

Your petitioner, ALLEN DAVY , respectfully represents to this court that he was this day appointed administrator de bonis non with will annexed of the above entitled estate; that he has previously investigated as to the real and personal estate of WILLIAM WALLACE HILL remaining to be administered, and finds that it consists solely of a one-eighth interest in the copyrights and renewal copyrights of certain children's songs and collections and compilations thereof, having value not in excess of \$25.00; that all of the assets of said estate which were collected by and came into the possession of CORINNE DOROTHY HILL, deceased, formerly executrix of said estate and also legatee under said will, were expended by her before her death and that under the terms of said will and the orders of this court she served as said executrix without giving bond or other security; that notice for the adjustment of claims against the estate of said decedent was duly published by CORINNE DOROTHY HILL, executrix of the estate of WILLIAM

WALLACE HILL, in the Chicago Daily Law Bulletin, weekly for three weeks, the first time being May 15, 1923, and the last May 29, 1923, and said notices were also duly posted on May 15, 1923, all in the manner then by statute provided; that said notice directed that claims against said estate be presented on the first Monday in July, 1923 to this court; that no claims against said estate were filed on or before July 2, 1923 nor at any date thereafter; that the amount reasonably due, LEO B. LOWENTHAL, formerly attorney for CORINNE DOROTHY HILL, deceased, formerly executrix of said estate, exceeds the value of said estate remaining unadministered; that no inventory was filed by CORINNE DOROTHY HILL, executrix of the estate of WILLIAM WALLACE HILL.

WHEREFORE, your petitioner prays that an order be entered herein adjudging and decreeing:

1. That your petitioner be excused from giving bond or other security on his personal bond for the faithful performance of his duties as said administrator.

2. That your petition be excused from publishing and posting further notice for adjustment of claims against said estate, and that your petitioner be authorized and directed to complete the administration of said estate without such publication or posting or the setting of a date for the adjustment of claims against said estate.
